

## RECREATIONAL ACTIVITY RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

To use the "WRECK ROOM," or "SPLATTER ROOM" a copy of this waiver must be completed and signed for every user. You must read the waiver in full and be certain that you understand the implications of signing. By signing this document you will waive or give up certain legal rights, including the right to sue or claim compensation following an accident. Please read carefully.

associated with the recreational use of the	WRECK ROOM or SPLATTER ROOM (hereafter collectively or individually
referred to as "Activity Room") in which I am	about to engage, located at: 901 Lucinda Avenue, Suite G, DeKalb, IL 60115.

The inherent risks and hazards include but are not limited to:

- 1) Injuries sustained from intentional or negligent misuse or abuse of the equipment by yourself or other users, including the failure to follow safety rules and guidelines or the express instructions given by Activity Room representatives.
- 2) Injuries sustained from unsecured or flying objects, debris, and shrapnel that may result from Activity Room activities.
- 3) Injuries sustained by stepping on or bumping into sharp objects that may pierce any part of the shoe. The participant is responsible for wearing shoes that will provide adequate protection against sharp objects.
- 4) Injuries and illnesses sustained or induced from Activity Room activities which may include slips, trips, and falls, malfunction of equipment used, flying debris or shrapnel, stress or injury to the body while participating in the Activity Room activities, bodily injury and open wounds, misuse or abuse of safety gear or equipment, negligence on the part of other persons, NEGLIGENCE ON THE PART OF THE RELEASEES.
- Physical and monetary injuries sustained due to my own personal negligence and/or the negligence of others, crowds, altercations with other patrons, the excessive use of alcohol, the prohibited use of illegal drugs, and the like.

Medical Condition: The Activity Room recreational activities may place unusual stresses on the body and are not recommended for persons suffering from asthma, epilepsy, cardio/respiratory disorder, hypertension, or skeletal, joint or ligament problems or conditions, and certain mental illnesses. Women who are pregnant or suspect they are pregnant, and persons who have consumed alcohol, are not recommended to engage in Activity Room activities. I have been advised to consult with my medical practitioner if I have any concern about my medical condition or fitness to engage in the activities.

I understand that the description of these risks is in no way complete and that all such dangers, both anticipated and

## unanticipated, can lead to illness, injury, permanent disability and death. # WRECK DEKALB LLC INSTRUCTIONS AND RESTRICTIONS ON USE

In order to participate in the Wreck Room or Splatter Room, Participant has read and agrees to the following rules and restrictions:

- a) Children under 12 years must be accompanied by an adult at all times and shall not use the equipment alone.
- b) No individual under the age of 10 will be allowed entry into the facility. This includes babies, toddlers, and young children.
- c) Close-toed shoes and legs covered attire is required for all individuals entering the facilities at all times.
- d) Hair must be pinned or in a ponytail; no loose hair allowed.
- e) A valid state issued ID is required for all individuals, of any age except minors, entering the facility, regardless of participation.
- f) A properly completed waiver, with accurate information matching the ID, is required for entry, regardless of participation. Improperly completed waivers will not be accepted and will need to be completed on site.
- g) Safety gear and equipment will be provided by Wreck DeKalb LLC and must be worn at all times while in the Wreck Room or Splatter Room. Personal equipment is not allowed.
- h) Participant shall immediately alert Owner to any damage to the Equipment (safety equipment and tools) or exterior walls of the Activity Room.
- i) The Participant SHALL NOT:
  - i. Permit the Activity Room to be used by any person who is not authorized to use such Activity Room;
  - ii. Use the Activity Room or permit it to be used in violation of law, or to commit a violation of law;
  - iii. Minors must be supervised at all times. Minors will not be allowed to use the equipment without the supervision of their parent or legal guardian.
  - iv. Alcohol or drugs, including marijuana, is strictly prohibited. Any individual showing any sign of intoxication or under the influence will not be allowed entry or will be required to leave.
  - v. Participant shall not push, fight, wrestle, or engage in combat-style activities while in the Wreck Room or Splatter Room.
  - vi. Participants shall not, under any circumstances, throw items at any Participant.

Violation of the rules and instructions will result in immediate termination of this agreement and expulsion from the premises without refund.

Participant acknowledges receipt of a copy of this Agreement and acknowledges having read and understood the foregoing and agrees to the terms herein.
